The undersigned on behalf of the Adarsha Vidyalaya Sangathan, Assam, invites online application through the official website of Directorate of Technical Education, Assam i.e. www.dte.assam.gov.in from eligible candidates who are permanent residents of Assam for filling up of the **vacant posts** of (1) **Graduate Teachers (Arts)**, (2) **Graduate Teacher (Science)**, and (3) **Graduate Teacher (Hindi)** for the Adarsha Vidyalayas of Assam, which are CBSE affiliated English medium schools, located in educationally backward blocks of Assam. The scale of pay is **Rs.14000/- to Rs. 49000/-** plus Grade Pay of **Rs. 8,700-** PM with other allowances as admissible. The appointments shall be made purely on contractual basis initially for a period of 11 months subject to renewal of the contract depending on the satisfactory performance. **For detailed advertisement please visit www.dte.assam.gov.in and download the advertisement from 31st January-2023.**

Candidates may apply for the following posts from 3rd of February-2023 midnight to 12th February 2023 midnight. No offline application will be accepted.

➤ **CONDITIONS OF RECRUITMENT:-**

(A) Minimum educational and professional qualifications for direct recruitment in the post of Graduate Teacher (Arts & Science).

1.	For the post of Graduate Teacher (Arts), the candidate must be Arts / Commerce Graduate or Post Graduate in Arts / Commerce having from recognized University with at least 50% marks in either Graduation or Post Graduation (or its equivalent) and Bachelor of Education (B.Ed.) from National Council for Teacher Education recognized Institution(s).
2.	For the post of Graduate Teacher (Science), the candidate must be Science Graduate or Post Graduate in Science having from recognized University with at least 50% marks in either Graduation or Post Graduation (or its equivalent) and Bachelor of Education (B.Ed.) from National Council for Teacher Education recognized Institution(s).
3.	In pursuance of the Govt. OM No. ASE.238/2014/213, dtd. 22.11.2019, those institutions having territorial jurisdiction outside the State of Assam but having a study centre in the State

	and such study centres if not recognized by DEC under UGC, the degrees / certificates issued by such off campus institutions shall not be considered as valid for the purpose of employment under Education Department. However, degrees / diplomas conferred by KKHSOU, IGNOU, IDOL under Gauhati University and Distance Education under Dibrugarh University shall be considered as valid for the purpose of employment.
4.	In respect of Secondary TET Candidate must obtain 60% marks in each paper for UR category and 55% marks for OBC/MOBC, SC, ST(P), ST(H) and PwD category.

(B) Minimum educational and professional qualifications for direct recruitment in the post of Graduate Teacher (Hindi).

1.	Pravin / Ratna in Hindi with 50% marks and degree qualification with 50% marks or post Graduate degree in Arts with 50% marks from any recognized University, Or BA with 50% marks and having Hindi as one of the subjects with 50% marks or post Graduate in Arts with 50% marks provided that he has passed BA with one of the subjects as Hindi with 50% marks in Hindi
2.	B.Ed. degree from any recognized University (PARANGAT to be treated as B.Ed. degree only for the purpose of Hindi teaching).
3.	In pursuance of the Govt. OM No. ASE.238/2014/213, dtd. 22.11.2019, those institutions having territorial jurisdiction outside the State of Assam but having a study centre in the State and such study centres if not recognized by DEC under UGC, the degrees / certificates issued by such off campus institutions shall not be considered as valid for the purpose of employment under Education Department. However, degrees / diplomas conferred by KKHSOU, IGNOU, IDOL under Gauhati University and Distance Education under Dibrugarh University shall be considered as valid for the purpose of employment.
4.	In respect of Secondary TET Candidate must obtain 60% marks in each paper for UR category and 55% marks for OBC/MOBC, SC, ST(P), ST(H) and PwD category

(i) As Adarsha Vidyalayas are CBSE affiliated English medium secondary school the candidates must have passed class 12th or equivalent Examination with English Language as one of the subjects or read from Class IX onwards in English Medium School..

(ii) Provided that for recruitment of teacher for teaching MIL subject, the candidate who passed HSLC examination with particular MIL subject shall be considered.

(iii) A candidate must be not more than 45 years of age as on 1st January, 2023.

(a) Criteria for Selection of Graduate Teacher (Arts and Science):

- I. 100 marks on percentage of marks in B.A/B.Com/B.Sc examination (in case of Major/Hons, the marks obtained in Major/Hons shall be taken into consideration).
- II. 100 marks on percentage of marks in Higher Secondary final examination.
- III. 100 marks on percentage of marks in B.Ed .final examination.
- IV. 100 marks on percentage of marks in TET examination.
- V. Explanation: For the purpose of calculation of marks under the categories mentioned in clauses (i)(ii), (iii) and (iv) above it may be clarified that if a candidate secures; for

example 60% marks in the particular examination he/she secure 60 marks out of 100 marks allotted in the concerned examination.

(b) Criteria for Selection (1) Graduate Teacher (Hindi):

- I. 100 marks on percentage of marks in BA Examination with the concerning language as one of the subjects or highest degree in the language i.e. Pravin / Ratna Examination in case of Hindi Teacher.
- II. 100 marks on percentage of marks in HS final examination.
- III. 100 marks on percentage of marks in B.Ed. final examination.
- IV. 100 marks on percentage of marks in TET examination

N.B. – In all the above mentioned category of teachers, any other marks obtained in any other examinations such as HSLC or equivalent, Post Graduation and any other professional qualification not mentioned in the NCTE guidelines the decision of Adarsha Vidyalaya will be final.

➤ **Other Criteria**

1. District-wise, , Subject-wise separate Merit Lists will be prepared for each category of the post.
2. A candidate must not be less than 18 years of age and not more than 45 years as on **1st January, 2023**
3. The eligible candidates shall apply online in the official website of DTE, Assam, i.e. www.dte.assam.gov.in from **12:00 AM of 3rd February-2023 to 12:00 AM of 12th February-2023**
4. No offline application will be accepted in this regard.
5. The Online Applications and documents submitted by the candidates will be verified along with their original testimonials, by the Adarsha Vidyalaya Sangathan, Assam (AVSA). The District-wise detailed schedule and venue for Screening/ Verification of documents will be notified in the official website. No TA/DA is admissible for verification process. District wise verification will be conducted centrally by Adarsha Vidyalaya Sangathan. Candidates will be informed collectively in the official website by the competent authority of Adarsha Vidyalaya Sangathan.
6. The Online Application and documents submitted by the candidate will be verified using modern technology with the help of DigiLocker, Govt. of India and by scanning Barcode or QR Code **for ensuring genuineness of the uploaded documents as well as by back office verification with the competent board/ council/ authority. But the authority if desires may conduct physical document verification at any point of time with proper notice.**
7. **The candidate must ensure genuineness of all the information/ documents uploaded against the online application and he/ she will be solely responsible for the information/ documents uploaded against his/ her online application. Once uploaded there will be no scope of correction in respect of the credential submitted by the candidate. Any discrepancy will lead to cancellation of the candidature.**
8. **The candidature will be cancelled forthwith, if any kind of fraudulence/ discrepancy regarding any information / documents uploaded by the candidate is established by appropriate authority at any point of time. The candidate will be debarred from any future recruitment under Government of Assam and subsequent legal action will also be initiated against such candidate.**
9. A candidate will mention and select the name of the districts for which the application is submitted.
10. When the candidates appear for the verification before the Adarsha Vidyalaya Sangathan they must produce original certificates, testimonials and documents that was uploaded during the application stage.
11. Reservation is not applicable, selection will be purely on merit basis.
12. **The Madrassa TET and CTET shall not be considered in the the recruitment process of Graduate Teacher ARTS / SCIENCE and HINDI**
13. The candidates having NOT CLEAR (NC) status against any qualification will not be eligible to apply.

7. High School TET mark sheet.
8. B.Ed. / Parangat Mark Sheet (1st Year & 2nd Year) and Certificate.
9. Caste Certificate (in case of SC/ ST(P)/ST(H)/OBC/MOBC) for ascertaining the TET qualification marks.
10. Scanned Signature.

Please Note:

- a. After successful submission of the online form, candidates shall take a print out of the form and submit the same along-with self-attested copies of mark-sheets and certificates in support of educational qualification, caste, TET, B.Ed. at the time of document verification before the Adarsha Vidyalaya Sangathan, candidates must also produce original documents that have been uploaded with the online application.
- b. After submitting the online application form, the candidates will get a Unique Number against the submitted application and will keep the printout of the unique Number for all future references.
- c. Candidates may note that failing to qualify in Screening/ Verification of documents will result cancellation of their candidature. Online communication in this regard will be entertained.
- d. The office will not be responsible for any lapse in submission of online application due to any technical problem.

11. Certificates in support of Schedule Caste / Schedule Tribe (Plains or Hills) / OBC / MOBC for ascertaining the TET qualification marks.
