Registration for the rally will start at 1100 hrs on 22 May 2024 and will close at 2300 hrs on 05 June 2024 on web portal Note: n.cdac.in. Only registered candidates issued with Provisional Admit Card are allowed to appear in the Recruitment Rally.

The recruitment test shall be conducted as per the details given above. Only candidates fulfilling the domicile requirements (as mentioned at 2. Para 1) and eligibility conditions are to report as per the date and time mentioned in Provisional Admit Card at the Rally Venue.

Candidates are to report at the designated rally venue on scheduled date/time as mentioned in the Provisional Admit Card without fail. Note They have to cater for any contingencies including late running of trains while planning their move.

Medical Assistant trade (For candidates with 10+2). Candidate should be unmarried and born between 02 January 2004 and 02 January 2008 (both dates inclusive).

Medical Assistant trade (For candidates with Diploma / B.Sc in Pharmacy). Unmarried candidate should be born between 02 January 2001 and 02 January 2006 (both dates inclusive). Married candidate should be born between 02 January 2001 and 02 January 2004 (both dates inclusive).

Candidate should have passed 10+2 / Intermediate / Equivalent Examination with Physics, Chemistry, Biology and English from Education Boards recognised by Central, State and UT with a minimum of 50% marks in aggregate and with 50% marks in English

OR

Should have passed two years' Vocational Course with non-vocational subjects i.e. Physics, Chemistry, Biology and English from Education Boards recognised by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

Candidate with Diploma / B.Sc in Pharmacy. Candidate should have passed Intermediate/ 10+2/ Equivalent Examination with (b) Physics, Chemistry, Biology and English with a minimum of 50% marks in aggregate and 50% marks in English. In addition, Diploma / B.Sc in Pharmacy with minimum 50% marks in aggregate with valid registration from State Pharmacy Council or Pharmacy Council of India (PCI) at the time of enrolment will be mandatory requirement.

Education Boards (for 10+2 or equivalent) recognized by Central, State and UT shall only be permitted. <u>Note-1</u>.

Exact aggregate percentage of marks before decimal as written in the marks sheet of 10+2/Intermediate/Equivalent/Diploma/B.Sc in Note-2. To be eligible to appear in the recruitment rally at Base Repair Depot, Air Force, Chandigarh the Domicile Requirement. candidates shall be required to satisfy the following conditions:-

The school / college / institute from where candidates have passed the qualifying examination should be within the geographical / (a) administrative limits of districts of States as mentioned in Para 1. If the name of State/District is not mentioned with the name of Institution in the certificate / marks sheet of qualifying examination, the candidate shall produce 'Domicile Certificate' issued by any Gazetted Officer in Revenue Department or any other official authorized by the State Government of the particular State.

Permanent Domicile of the districts of States as mentioned at Para 1 who has passed the qualifying examination from anywhere in (b) India shall produce the Domicile Certificate prior to commencement of examination from appropriate authority as given in sub-paragraph 5 (a) above.

Sons of serving Air Force personnel [Officer/Airmen/NCs(E) and Unit cadre Civilians paid from Defence Estimates] whose father/ (c) mother is presently serving in any Air Force Unit/ any other Organisation located in the districts of States as mentioned at Para 1 irrespective of their domicile status, shall be permitted to appear in the rally subject to production of latest SOAFP (Son of Air Force Personnel) Certificate (format available on www.airmenselection.cdac.in).

9 Only Sikh candidates, whose religion prohibits cutting of the hair or shaving of face, shall be permitted to grow hair and/or retain beard and moustache. Candidates discharged from Indian Army/Indian Navy/any other Government Organisation shall also be eligible subject to their discharge with NO ADVERSE ENTRIES. Such candidate has to declare at the rally venue that he is an Ex-employee of above said organisations and produce original Discharge Certificate. In case of serving individuals, they must be in possession of NOC from their employer at the time of rally. If any candidate does not disclose the fact of being employed or that of being an Ex-employee, his candidature shall be cancelled at any stage during the selection process and if selected, shall be liable for discharge/ dismissal from the service for hiding the fact of his employment. Candidates discharged from Indian Air Force for any reason are not eligible to appear in the rally. Candidates debarred permanently from any previous Air Force exam due to malpractices or any unfair activity are not eligible to appear in the rally. Candidates discharged from Indian Army/Indian Navy/Any other Government Organisation. Original and four Self-attested photocopies of Discharge Certificate (as issued from Indian Army/Indian Navy/Government Organisation).

Original and four self-attested photocopies of NCC 'A', 'B' or 'C' Certificate (if applicable). (k)

Under no circumstances the candidates shall be permitted to appear in the rally without original educational marks Note. sheets/passing certificates & documents mentioned above in paragraph 11. Candidates below 18 years of age are to get the consent form signed by their parent / guardian. However, candidates Note: above 18 years of age can sign the consent form themselves.

TERMS AND CONDITIONS

Enrolment shall be for an initial period of 20 years (subject to service condition) which may be extended up to the 12. Tenure & Training. age of 57 years (subject to service conditions). Initially, candidates shall be sent for a Joint Basic Phase Training (JBPT) at designated Basic Training Institute. On successful completion of JBPT, candidates will be sent for trade training of specific duration which shall include security training or any Retired/Discharged/ Deceased and they are residing in the districts of States as mentioned at Para 1 shall be permitted to appear in the rally other training as per service requirements. Training is however liable to be terminated at any time if the trainee fails to achieve the required standards in academics, profession, physical fitness and discipline or is found to be medically unfit. AFTER SUCCESSFUL COMPLETION OF ALL STAGES OF TRAINING, THE AIRMEN SHALL BE DEPLOYED ON JOBS AS PER IAF REQUIREMENT. TRADE ALLOTTED SHALL NOT BE CHANGED ON CANDIDATE'S REQUEST ON ANY GROUNDS.

Sons of Air Force personnel [Officers/Airmen/NCs(E) and Unit Cadre Civilians paid from Defence Estimates] whose father/mother is (d) subject to production of proof of minimum stay of one year along with original and photocopy of Service Book/Discharge Book/Casualty Service Certificate/Service Particular Certificate (issued from DPO-3/DAV, as applicable) in case of Officers/Airmen/NCs(E) and a Certificate duly signed by OIC Civil Admin and countersigned by CO/C Adm O of the last served unit, in case of Civilians.

- Mandatory Medical Standards. General Medical Standards are as follows: -6.
 - Minimum acceptable height is 152.5 cms. (a) Height.
 - The chest should be well proportioned and well developed with the minimum range of expansion of 5 cms. (b) <u>Chest</u>.
 - Proportionate to height and age as applicable for IAF. (c) Weight.
 - (d) Candidate should have normal hearing i.e. able to hear forced whisper from a distance of 6 meters by each ear separately. Hearing.
 - Should have healthy gums, good set of teeth and minimum 14 dental points. (e) Dental.
 - (f) Visual Standards. Vision requirements are as follows:-

(g) Corneal Surgery (LASIK/RK/PRK) is not acceptable.

Candidates should bring latest prescription (not older than one month) and spectacles for corrected vision, if used. The prescription Note: must bear the diopter measurement, name, signature, stamp and registration number of Ophthalmologist and date of prescription should be within a month prior to appearing for medical examination.

Candidate should be of normal anatomy without loss of any appendages. He should be free from any active or General Health. latent, acute or chronic, medical or surgical disability or communicable diseases, infection and skin ailments. Candidate shall be physically and mentally FIT to perform duty in any part of the world, in any climate and terrain.

Consumption of Narcotic Drugs and Psychotropic Substance (NDPS). Consumption of Narcotic Drugs and Psychotropic substances banned under the NDPS Act 1985 shall be a reject criteria for selection into the IAF and airmen found either in possession or storing or distributing or consuming such drugs and substances after enrolment shall be liable for disciplinary action including dismissal from the IAF. ZERO TOLERANCE POLICY TO ALCOHOLISM AND SUBSTANCE ABUSE IS FOLLOWED IN IAF.

8. Permanent body tattoos are not permitted, however, tattoos only on inner face of the fore arms (inside of elbow to the Body Tattoo. wrist), back (dorsal) part of the hand/reverse side of palm and Tribals with tattoos which are as per custom and traditions of their tribes may be considered. Offensive, obscene, indecent, sexist or racist tattoos are prohibited regardless of location on the Body. However, right to consider a tattoo acceptable or unacceptable will rest with the Selection Centre. Candidates with permanent body tattoos are to submit two postcard size photographs (close up and distant view) with details of size and type of the Tattoo.

Note-1: Candidates will not be permitted to stay with their family during the training period.

Unmarried candidates will not be permitted to get married till successful completion of their ab-initio training Note-2:

Pay & Allowances. During training, a stipend of Rs. 14,600/- per month shall be paid. On completion of training the starting gross 13. emoluments at the minimum of scale of pay including Military Service Pay (MSP) is Rs. 26,900/- per month. In addition, dearness allowance (as applicable) which, in subsequent years, may rise as per the career progression of the individual.

Other allowances such as Transport Allowance, Composite Personal Maintenance Allowance (CPMA), Leave Ration Allowance (LRA), 14 Children Education Allowance, HRA etc. shall also be admissible to Airmen, as per relevant government instructions.

Airmen shall be permitted to pursue higher education qualification only after acquiring prescribed skill grade in their 15. Higher Education. trade and prescribed years of service as stated in HRP.

Perks such as ration, clothing, medical facilities, accommodation, CSD facilities, Leave (60 days annual and 30 days 16. Perks. casual in a calendar year as a privilege, subject to service exigencies). Recreational facilities, transport for school going children and Leave Travel Concession (LTC) shall also be provided as per the existing rules. Group Insurance Cover of Rs. 55 Lakhs at a premium of Rs. 3200/- per month for all Airmen and facility of Group Housing Scheme are also extended.

As a Medical Assistant, you are to be trained in nursing and first-aid. You will also 17 Job Specification of Medical Assistant Trade. be involved in management of medical stores, dispensaries and ward supervision and other Air Force duties



SELECTION PROCEDURE

18 Verification of Eligibility. Original Educational Certificates (10th passing Certificate, 12th passing Certificate & mark sheet and Original Degree/Diploma Certificate & Mark Sheets of B.SC/Diploma in Pharmacy) and other required applicable original documents like NCC 'A', 'B' or 'C' certificate, Son of serving Air Force Personnel (SOAFP) certificate (or), Discharge Book, Service Book, Service Particular Certificate/Casualty Service Certificate (or) Discharge Certificate (if discharged from Army/Navy/Government organisation), Consent form, passport size colour photographs and domicile proof (as per Para 5 above) shall be required and scrutinized/verified at the examination venue prior to commencement of Physical Fitness Test to ascertain the prima-facie eligibility. Detailed verification will be carried out later in respect of candidates who pass Physical Fitness Test and subsequently the Written Test. Those candidates who do not meet the laid down educational criteria shall be rejected during Initial verification of original certificates & mark sheets prior to conduct of Physical Fitness Test and also during Detailed Verification on clearing the Physical Fitness Test as well as Written Test or if found ineligible at any subsequent stage.

The original Passing Certificates / Marks Sheets will not be retained by the Selection Centre. The same will be Note: returned to the candidates on completion of Detailed Verification.
