Applications are invited from local residents of Darrang District in *bio-data* format along with two passport-size photographs for the selection of Para Legal Volunteers (PLVs) who are willing to work under the District Legal Services Authority (DLSA), Darrang.

**Eligibility Criteria:**

1. The applicant must be a citizen of India and a local resident of Darrang District.
2. The applicant should have passed at least matriculation, possess the capacity for overall comprehension, and have a mindset to assist the needy in society. The applicant must demonstrate compassion, empathy, and concern for the upliftment of marginalized and weaker sections of society. They must also have an unflinching commitment to the cause, which should be reflected in their work.

Eligible applicants may belong to the following groups:

- a. Teachers (including retired teachers)
  - b. Retired Government servants and senior citizens
  - c. MSW students and teachers
  - d. Anganwadi Workers
  - e. Doctors/Physicians
  - f. Students and Law Students (till they enrol as lawyers)
  - g. Members of non-political, service-oriented NGOs and Clubs
  - h. Members of Women Neighbourhood Groups, Maithri Sanghams, and other
  - i. Self-Help Groups including of marginalized/vulnerable groups
  - j. Educated Prisoners with good behaviour serving long-term sentences in prisons.
  - k. Widows of deceased defence personnel
  - l. Ex-servicemen or their dependents residing in civilian areas
  - m. Spouses or adult children of currently serving defence personnel
  - n. Any other person whom the District Legal Services Authority deems fit to be identified as a PLVs.
3. The post of PLV does not carry any salary, wages and remuneration except honorarium fixed by the National Legal Services Authority/ Assam State Legal Services authority from time to time.
  4. The filled-up application should reach the office of the Secretary, DLSA, Darrang, on or before **20.01.2026**. The applicant must provide a mobile number in the *bio-data* for further communication.

5. Incomplete applications will be rejected without assigning any reason. No application will be entertained after the last date of submission.
6. The decision of the Selection Committee in short listing the eligible candidates for walk-in interview and in the selection will be final.
7. Eligible candidates will have to appear for a walk-in interview before the Selection Committee.
8. The date of the walk-in interview will be notified on the official website i.e. [www.darrangjudiciary.gov.in](http://www.darrangjudiciary.gov.in). shortly.
9. Selected PLVs will be required to undergo a training programme as per the schedule of DLSA, Darrang. In case of any objection regarding selection, the decision of the selection committee shall be final and binding.
10. The list of shortlisted applicants will be uploaded on the official website i.e. [www.darrangjudiciary.gov.in](http://www.darrangjudiciary.gov.in).
11. Canvassing in any form will lead to disqualification.
12. No TA/DA will be provided for attending the interview.
