Application in prescribed form are hereby invited from the eligible candidates, who are citizens of India as defined in article 5 & 6 of the Constitution of India, for the following vacant posts under the establishment of the Chief Judicial Magistrate, Kokrajhar:-

**Eligibility Criteria**

1. Minimum qualification is Class **VIII** passed but those who have passed **HSSLC (10+2)** or above shall be ineligible to apply for the posts. Candidates possessing special IT skills may be given preference.
2. The candidate must not be less than **18 years** and not more than **40 years** of age in respect of General Category as on 01.02.2026. The upper age is relaxable as per Govt. norms.

**REQUIRED DOCUMENTS ALONG WITH THE APPLICATION:**

- A. Self-attested copies of the educational/other qualification certificates.
- B. The candidate should paste their recent passport size colour photograph in the given space of the application form and sign across it and 02 (two) copies of photograph should be stapled on the top right corner of the application form.
- C. Self-attested copy of Caste Certificate (in case of reserved category candidates).
- D. Self-attested Copy of valid Employment Exchange Registration Certificate.

**HOW TO APPLY / OTHER TERMS & CONDITIONS**

1. The candidate must submit duly filled up application in prescribed form along with self-attested copies of testimonials as mentioned above. The envelope containing the application form should be superscribed as "**APPLICATION FOR THE POST OF PEON (GRADE IV)**". The application should reach the Office of the undersigned on or before 24<sup>th</sup> Feb 2026 till 04.30 P.M. 2. Application shall be written neatly in **CAPITAL / BLOCK LETTERS** only.
3. Candidates who are already in Govt. Services must apply through proper channel.
4. A provisional **Select List** of candidates eligible for appearing in the Viva-Voce/ interview along with **Reject List** will be uploaded in the official website of the Kokrajhar District Judiciary in due course of time.
5. Date of Interview / Test will be notified later on.
6. If any candidate is found to have suppressed his educational qualification or give any wrong information at the time of applying for the post, his candidature shall be liable to be rejected or terminated at any point of time.

7. Incomplete applications, applications without proper supporting documents, without applicant's signature, application form filled in small letter, enclosure details not filled, application form other than prescribed format, photograph not self-attested, spare photograph not enclosed, double / multiple application, any of the required document not enclosed or not self-attested etc will be summarily rejected.
8. Applications submitted in any other mode, except as indicated will be summarily rejected without any communication. Applications received after due date will be rejected. No application will be entertained after the aforesaid time schedule including the application submitted through post.
9. Candidates who are already in Govt. service (temporary or permanent) will have to submit "No Objection Certificate" from the present authority.
10. If, information submitted by an applicant in his/her application found suppression of material facts including educational qualification, after selection, the same will be forfeited and criminal proceedings will be initiated for playing fraud and suppression of material facts and in such cases, candidate have no right to claim for selection and same will be filled up as per decision of the Selection Board and Board decision will be the final.
11. Candidate will be responsible for any mistake made by him/her in the application form.
12. Canvassing directly or indirectly will lead to immediate disqualification of the candidature.
